


Movement of Sales Amount*


2008 Sales Breakdown by Fields


2008 Clinical/Devices/Food & Supplement Sales Breakdown by Services


2008 Clinical Development Sales Breakdown by Phases




2008 Sales Breakdown by Clients





Movement of Number of Employees*





Employment in 2008



 \bigstar 1 Project =1 service per protocol



2008 Clinical Projects Breakdown by Phases


